The Environment Agency gives notice that the Shoreline Management Plan 4 – The Wash (Gibraltar Point to Old Hunstanton) was adopted on the 18th November 2010. It is available for inspection alongside its Environmental Report and a Statement of Environmental Particulars (in line with Regulation 16(4)) at the locations set out below.

The Shoreline Management Plan 4 – The Wash (Gibraltar Point to Old Hunstanton) outlines the approach to shoreline management for The Wash over the next 100 years. The Plan has been developed by a partnership of fourteen organisations, with the Environment Agency as the lead authority.
